

RIDER AGREEMENT COVERED BRIDGE BIKE CLASSIC

To have a safe and effective event, we ask each rider to read and agree to the following:

1. I agree to obey all traffic laws of the State of California, including laws relating to lane change, stop signs, merging traffic, etc.
2. I agree to have a cooperative attitude relating to all SAG (support) vehicles and staff helpers, CHP officers and other law enforcement officials. I recognize that they are aiding in the overall safety of our event.
3. I agree to ride single-file, except for passing other bike riders, and will undertake such maneuvers only after checking to ensure safe conditions exist. I will attempt to stay on the right side of my lane. I will avoid weaving (or other erratic maneuvers).
4. I will wear a helmet throughout the ride, and will display at all times tags or identifiable rider ID to clearly identify myself as an official part of this ride.
5. I understand that if law enforcement or CBBC officials receive repeated complaints about illegal acts on my part I may be asked to drop out of the ride and will waive my right to participate in future Covered Bridge Bike Classics.

**HOLD HARMLESS AGREEMENT
WRITTEN ASSUMPTION OF RISK AND RELEASE**

In addition to any implied assumption of risk provided by law, the undersigned, for himself/herself and personal representatives, assigns, heirs and next of kin:

Hereby releases, waives, discharges and covenants to hold harmless Healing Nations Non-profit, the County of Stanislaus, the County of Tuolumne, the County of Merced, the County of Mariposa, the State of California Department of Highway Patrol, the State of California Department of Transportation or any other individual or entity involved in the "Covered Bridge Bike Classic", as well as their agents, servants and employees, from any claims for property damage, bodily injury or death resulting from any accident or occurrence.

The undersigned is fully aware of the risks and hazards inherent in participating in this event, including the possibility of losing control of my bike, crashing, falling, colliding with natural obstacles as well as other riders and/or vehicles, becoming ill, being bitten by insects, animals or reptiles, as well as other risks. I hereby elect to voluntarily participate in this event, knowing the risks and hazards, and voluntarily assume all risks of loss, damage or injury that may be sustained by me while participating in said event.

In consideration of being allowed to participate in this event with its services, foods and awards, I hereby agree to hold harmless and indemnify Healing Nations Non-Profit from any claim, loss or action taken by me.
